<b>1. INDELICATE (ADJECTIVE):</b> (असभ्य): <b>insensitive</b>
<b>Synonyms:</b> tactless, undiplomatic
<b>Antonyms:</b> tactful
<b>Example Sentence:</b> Forgive me asking an indelicate question, but how are you off for money?
<b>2. ABRUPT (ADJECTIVE):</b> (आकस्मिक): <b>sudden</b>
<b>Synonyms:</b> immediate, instantaneous
<b>Antonyms:</b> gradual
<b>Example Sentence:</b> I was surprised by the abrupt change of subject
<b>3. PRESUMPTUOUS (ADJECTIVE):</b> (अभिमान): <b>brazen</b>
<b>Synonyms:</b> overconfident, arrogant
<b>Antonyms:</b> timid
<b>Example Sentence:</b> The man seemed too presumptuous to be a humble leader for the nation.
<b>4. DISMISS (VERB):</b> (खारिज करना): <b>banish</b>
<b>Synonyms:</b> set aside, abandon
<b>Antonyms:</b> entertain
<b>Example Sentence:</b> He suspected a double meaning in her words, but dismissed the thought.
<b>5. NORM (NOUN):</b> (मानक): <b>standard</b>
<b>Synonyms:</b> usual, normal
<b>Antonyms:</b> the exception
<b>Example Sentence:</b> Women used to stay at home to take care of the children, but that's not norm.
<b>6. ETHICS (NOUN):</b> (नीति शास्त्र): <b>morals</b>
<b>Synonyms:</b> morality, moral code

<b>Antonyms:</b> corruption
<b>Example Sentence:</b> Ethics enter into every sphere of life.
<b>7. SUMMON (VERB):</b> (बुला भेजना): <b>send for</b>
<b>Synonyms:</b> call for, ask for
<b>Antonyms:</b> discharge
<b>Example Sentence:</b> A waiter was immediately summoned.
<b>8. INDUCE (VERB):</b> (मनाना): <b>persuade</b>
<b>Synonyms:</b> convince, prompt
<b>Antonyms:</b> dissuade
<b>Example Sentence:</b> The pickets induced workers to stay away.
<b>9. MANIFOLD (ADJECTIVE):</b> (अनेक): <b>many</b>
<b>Synonyms:</b> numerous, multiple
<b>Antonyms:</b> few
<b>Example Sentence:</b> The implications of this decision were manifold
<b>10. PRESUMPTIVE (ADJECTIVE):</b> (प्रकल्पित): <b>conjectural</b>
<b>Synonyms:</b> speculative, tentative
<b>Antonyms:</b> definitive
<b>Example Sentence:</b> The muzzle probably formed a snout in life; and there is presumptive evidence.
